\$500,001 to \$1,000,000	\$2,169.00 for the first \$500,000	Plus \$3.00 for each additional \$1,000 or fraction thereof

Post Facto Permits	In instances where work begins prior to obtaining a required permit, the building permit fees shall be doubled	
Permit Cancellation Fee		
Permit Cancellation Fee	Refunds for cancelled permits shall be subject to a processing fee in the amount of 25% of the original permit fee (\$10.00 min.)

Standard Plan Review Fee	25% of building permit fee amount (\$10,000.00 max)	
Express Plan Review Fee	<u>Single-Family, Duplexes & Accessory Structures:</u> \$200.00 <u>All Other Building Types:</u> 50% of Standard Plan Review Fee (\$500.00 min.) <i>Note: Express plan review requests will be processed within three (3) business days following receipt of a completed submittal. Express plan review fees are in addition to standard plan review fees, and shall be paid at the time of submittal. Due to the complexity of certain plan reviews, please note that the Building Official reserves the right to deny a request for an express plan review.</i>	
Revision to Approved Plans	<u>Single-Family, Duplexes & Accessory Structures:</u> - Major Revision: \$100.00 - Minor Revision: \$50.00 <u>All Other Building Types:</u> - Major Revision: \$400.00 - Minor Revision: \$200.00 <i>Note: "Major revisions" shall include structural modifications, life/safety items, the review of alarm/sprinkler plans, and any other revision which the Building Official estimates will take more than one (1) hour of total staff time to complete. All other revisions shall be considered "minor revisions." All fees shall be per occurrence.</i>	
² <i>Plan Review Fees Non-Refundable: Fees for plan review, express plan review, and revisions to approved plans shall be non-refundable in the event of a cancelled/refunded building permit.</i>
