4. Town of Fort Mill requires Vendors to have General Liability Insurance and name the Town of Fort Mill as **ADDITIONAL INSURED.**

Insurance Details:

You must ask your Insurance Agent to submit a Certificate of Liability Insurance (COI) Form directly to the Town of Fort Mill within 3 days of approval to be a Vendor at the Farmers Market. This is the information that **MUST** be included on the COI:

- Minimum \$1,000,000 General Liability Insurance & In the Certificate Holder Section of the COI, Town of Fort Mill must be listed as Additional Insured.

\*Vendors should check with their insurance carriers and provide their own personal, general, and product liability insurance as warranted for your business and products. The Town of Fort Mill will not supply insurance for individual Vendors.
